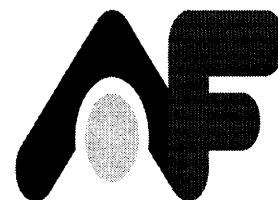


1. Punctajul minim necesar promovarii probei scrise a fost de minimum 50 de puncte.
